The Health Guarantee of this AKC or CKC registered purebred Shih Tzu Puppy/ Adult dog is based on the following terms and conditions:

1. The purchase price of the puppy or adult dog is \$_____ with Full or Limited registration as defined by AKC (American Kennel Club). Shipping is \$335.00. Total Due is \$_____. Monies are non-refundable.
2. A one year after sale Replacement Warranty is given for any life threatening congenital disease that caused said puppy to expire if the following stipulations are met:
 - A notarized Veterinarian Report with findings stating, to a medical certainty, that the death was in fact caused from the prenatal state, will be required. Buyers will be required to send the notarized Veterinarian’s Report by registered mail along with all of the puppy’s medical records. Seller’s Veterinarian must confirm and agree with the diagnosis.
 - The Seller will then give Buyer a replacement puppy of equal value and the same gender, from the next available litter. Replacement Warranty will be terminated if

puppy was found to be abused, neglected, or does not have up to date records of vaccinations, or if the dog has produced offspring.

2A. If the dog is already one year old at the time of sale, the Buyer will have 5 business days from the time the adult dog is received to have the dog examined by a vet. If at the time of examination, the dog is found to have a life threatening congenital disease, the purchase price of the dog will be refunded if the following stipulations are met:

- A notarized Veterinarian Report with findings stating, to a medical certainty, that the life-threatening condition was in fact caused from the prenatal state, will be required. Buyers will be required to send the notarized Veterinarian's Report by registered mail along with all of the dog's medical records. Seller's veterinarian must confirm and agree with the diagnosis.
3. The Seller will assume no shipping costs associated with the sale or Replacement Warranty.
 4. To the best of the Seller's knowledge and belief, this puppy or adult dog is in good sound health, free from symptoms of contagious and infectious diseases at the time of sale. No further health guarantee is made or implied. If the Buyer believes this puppy or a dult dog to be sick, the animal should be immediately taken to a veterinarian of the Buyer's choice at the Buyer's expense.
 5. As of the date of delivery, the puppy or adult dog has received age appropriate vaccinations and the Buyer has been informed of these. This warranty does not cover hypoglycemia or diseases for which vaccinations could prevent.
 6. The Seller assumes no responsibility for medical expenses, mortality, landlord's disapproval, allergy, or any other undesirable circumstances once the dog has left the seller's premises.
 7. The size and color a puppy will mature to, is only an estimate based on Seller's experience and traits recognition. No guarantees are made as to adult color and size.
 8. Hernias must be certified by a veterinarian, to be currently life threatening and to have rendered the puppy unfit for purchase.
 9. If the puppy or adult dog is sold with full AKC or CKC registration rights, Seller cannot guarantee the fertility of a male puppy, female puppy or adult dog. The Seller cannot guarantee breeding success or show success. It is the Buyer's sole responsibility for bills incurred from breeding said dog. Limited AKC or CKC registration papers will be released for companion pets after proof of spay or neuter is received by Seller.

10. No charge backs will be filed through credit card companies or PayPal on this transaction for any reason.
11. Any disputes will be litigated in Tarrant County, State of Texas, USA at the buyer's expense.
12. Warranty applies to the original Buyer only, and is not transferable if the puppy or adult dog is resold.
